(74-2010) To award Bid 2010-011 for the purchase of a new Triple Combination Pumper for the Lewiston Fire Department to Pierce Manufacturing Inc., Appleton WI, at the bid price of \$428,044 and to accept the Discount Option #2 for pre-payment of 90% to reduce the net price to \$412,720. In addition, to authorize the addition of the purchase of FireCom Headset System and Top Mounted Deck Gun at an additional cost of \$9,307 making the total award amount \$422,027.
