

8: 5-205.11.(B): N: Hand washing facility being used for other than hand washing.

INSPECTOR NOTES: Kitchen hand wash sink basin being used as storage with busy service. Keep area free from objects to promote hand washing and assesability. *COS

46: 4-302.14: N: No chemical test kit available.

INSPECTOR NOTES: Quat sanitizer used for beverage glasses in 3 bay. No test strips are on hand to test solution. Buy Quat test strips and use to maintain 200-400 ppm.

54: 6-501.14.(A): N: Ventilation not clean.

INSPECTOR NOTES: Kitchen hood has not been professionally cleaned from baffles to the outdoor fans/exhaust. Have the entire system professionally cleaned by 3rd party Hood cleaning system.



Violation Correction Timeframe

Critical violations should be corrected on site, but in any event, within 10 days. The licensee must contact your inspector, Laurie Davis when the critical violation has been addressed at 207-592-5573 or laurie.davis@maine.gov. Non-critical violations must be corrected within 30 days. Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation

"Critical violation" means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.

Additional Inspection Fee

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

Document Retention/Posting

Pursuant to the Maine Food Code, the establishment's current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM certificates must be posted in a conspicuous area and must be available to the Department upon request.
