**Alternatives to Household Hazardous Waste Chemicals**

<b>General purpose cleaner</b>	1/4 cup borax, 1/4 cup white vinegar, 2 gallons hot water. Stir to dissolve. Use mop or sponge to clean. Alternative products: Murphy's Oil Soap or Citra-Solv.
<b>Scouring powder</b>	1 cup baking soda mixed with 1/4 cup borax. Dampen sponge and scoop up mixture. Rub on surface. Let "rest" then rinse well. Alternative product - Bon Ami.
<b>Paint thinner</b>	Let paint particles settle, then pour off clear liquid and reuse.
<b>Bug sprays/ insecticides</b>	For gardens, use companion planting and Integrated Pest Management. Plant disease resistant seeds. Pour a line of cream of tartar, red chili pepper, paprika or dried peppermint where ants are entering the house.
<b>Insect repellent</b>	Do not wear scented products outdoors. Burn citronella candles, punk wood, or incense. Alternative product - Bite Blocker.

## What products should I bring to the Collection?

Look for the words: **Caution, Warning, Poison, Corrosive, Toxic, Volatile, Flammable or Danger** on the label.

## How Do I Dispose of Hazardous Waste?

- ◆ **What is a unit? One unit equals up to 5 gallons of liquid waste or up to 20 pounds of dry waste or a combination.)**
- ◆ Residents from participating towns may bring up to 2 units to the Depot at no charge. More than 2 units will be subject to a per unit charge of **\$30.00**.
- ◆ Residents from non-participating towns are subject to a per unit fee and must pay the contractor in cash or by check. (**\$30.00 per unit**)
- ◆ Keep hazardous waste in original container **DO NOT MIX. If leaking wrap in plastic bag and place in a separate box.**
- ◆ Place materials in a secure box.
- ◆ Place secured box in trunk or truck bed.
- ◆ Remain in your vehicle.
